

RESOLUTION NO. 2020-4


CALLERY BOROUGH, BUTLER COUNTY, PENNSYLVANIA

**BE IT RESOLVED** that, following an affirmative vote by Borough council, it is hereby authorized and directed that Callery Borough (in keeping with the provisions and authority granted to it by Act 15 of 2020, as signed into law on April 20, 2020) does hereby extend the period by which property taxes may be paid "at Face" through and until November 30, 2020. As such, no penalties, fees or interest shall be due if the tax is paid in full before November 30, 2020. This Resolution shall only be effective for the tax period of 2020 and will be automatically null and void as of December 1, 2020.


