

ORDINANCE NUMBER 2017-14

CALLERY BOROUGH, BUTLER COUNTY, PENNSYLVANIA

**AN ORDINANCE ADJUSTING THE COMPENSATION PAID TO
BOROUGH OFFICIALS**

WHEREAS, Callery Borough council previously set the compensation rates for Borough officials;

WHEREAS, under Section 1001(e) of the Borough Code, council members may receive a maximum compensation of \$1,875 per year;

WHEREAS, under Section 10A04 of the Borough Code, the mayor may receive a maximum compensation of \$2,500 per year;

WHEREAS, council desires to adjust the compensation paid to council members and the mayor and to rescind all previous compensation rate ordinances or resolutions to reflect this adjustment; and

WHEREAS, council hopes the adjustment will encourage more residents to consider serving as public officials.

NOW, THEREFORE, it is hereby enacted and ordained, pursuant to the authority vested by the Borough Code, that the Code of the Borough of Callery, Chapter 13, Salaries and Compensation, Article I, Borough Council, is hereby revised, in its entirety, as follows:

**CHAPTER 13
SALARIES AND COMPENSATION**

**ARTICLE I
BOROUGH OFFICIALS**

§ ~~13~~1. The compensation paid to the president of council shall be One Hundred Fifty Dollars (\$150) per month, payable quarterly.

§ ~~13~~2. The compensation paid to all other members of council shall be One Hundred Dollars (\$100) per month, payable quarterly.

§ ~~13~~3. The compensation paid to the mayor shall be One Hundred Fifty Dollars (\$150) per month, payable quarterly.

§ ~~13~~4. To be eligible to receive compensation Borough officials are required to attend at least one (1) advertised public meeting held by council during the month.

§ ~~13~~5. The adjusted compensation rate for all Borough officials currently holding office shall become effective at the beginning of their next term of office.

13-106

§ 1306. The Borough treasurer shall withhold all appropriate federal, state and local taxes from the quarterly payments made to all Borough officials.

§ 1307. All other ordinances or regulations, or parts of such ordinances or regulations, in conflict with this Ordinance or inconsistent with its provisions, are hereby repealed to the extent necessary to give this Ordinance full force and effect.


§ 1308. If any of the provisions of this Ordinance or the application thereof to any person or circumstance are held invalid, such invalidity shall not affect other provisions or applications of the Ordinance which can be given effect without the invalid provision or application, and to this end, the provisions of this Ordinance are declared to be severable.

§ 1309. EFFECTIVE DATE. This ordinance shall become effective on December 31, 2017.




