

ORDINANCE NUMBER 2018-18

CALLERY BOROUGH, BUTLER COUNTY, PENNSYLVANIA

**AN ORDINANCE AMENDING THE CODE OF ORDINANCES
BY REPEALING CHAPTERS 9, 35, and 44 IN THEIR ENTIRETY**

WHEREAS, Chapter 9, Borough Council, of the Borough of Callery Code of Ordinances (“Code Book”) adopted by Ordinance No. 2, on August 10, 1905, as amended, provided for the appointment of officials and standing committees of the Borough;

WHEREAS, Chapter 35, Curfew, of the Code Book, adopted by Ordinance No. 48, on January 14, 1965, as amended, established a curfew for children age 16 and younger;

WHEREAS, Chapter 44, Fire Prevention, of the Code Book, adopted by Ordinance No. 36, on November 27, 1957, as amended, prohibited the manufacture and sale of explosives in the Borough; and

WHEREAS, council has determined that is its appropriate and in the best interest of the Borough to repeal Chapters 9, 35, and 44 of the Code Book in their entirety.

NOW, THEREFORE, IT IS HEREBY ORDAINED AND ENACTED, pursuant to the authority vested by the Borough Code, that Chapter 1, General Provisions, of the Code Book is hereby amended by the addition of the following:

**CHAPTER 1
GENERAL PROVISIONS**

**ARTICLE 2
REPEALER – CHAPTERS 9, 35, and 44**

§ 1-201. Chapter 9 of the Code of Ordinances is hereby repealed in its entirety.

§ 1-202. Chapter 35 of the Code of Ordinances is hereby repealed in its entirety.

§ 1-203. Chapter 44 of the Code of Ordinances is hereby repealed in its entirety.


§ 1-204. Severability. The provisions of this Ordinance are severable, and if any clause, sentence, subsection, section, article or part thereof shall be adjudged by any court of competent jurisdiction to be illegal, invalid or unconstitutional, such judgment or decision shall not affect, impair or invalidate the remainder thereof but shall be confined in its operation and application to the clause, sentence, subsection, section, article or part thereof rendered. It is hereby declared to be the intent of the council that this ordinance would have been adopted if such illegal, invalid or unconstitutional clause, sentence, subsection, section, article or part thereof had not been included therein.

§ 1-205. Effective Date. This Ordinance shall become effective five (5) days after enactment.


