SANITARY SEWER RULES AND REGULATIONS

AN ORDINANCE REVISING CHAPTER 64, SANITARY SEWER RULES AND REGULATIONS, OF THE CODE OF THE BOROUGH OF CALLERY TO ADOPT RULES, REGULATIONS AND STANDARDS ADOPTED BY THE EVANS CITY WATER AND SEWER AUTHORITY TO GOVERN THE CONSTRUCTION, CONNECTION, USE AND MAINTENANCE OF ALL SANITARY SEWER LATERALS AND ASSOCIATED EQUIPMENT AND FACILITIES WITHIN THE BOROUGH

WHEREAS, Callery Borough council previously adopted Chapter 64, Sanitary Sewer Rules and Regulations, of the Code of the Borough of Callery to establish comprehensive rules, regulations and standards governing the construction, connection, use and maintenance of the Borough's sanitary sewer collection system; and

WHEREAS, on December 4, 2017, Callery Borough sold its sanitary sewer collection system to the Evans City Water and Sewer Authority ("Authority"); and

WHEREAS, council deems it necessary and appropriate to revise Chapter 64, Sanitary Sewer Rules and Regulations, of the Code of the Borough of Callery, in its entirety, to adopt rules, regulations and standards adopted by the Authority to govern the construction, connection, use and maintenance of sanitary sewer laterals and associated equipment and facilities for the Authority's sanitary sewer collection system located within the Borough.

NOW, THEREFORE, IT IS HEREBY ENACTED AND ORDAINED, pursuant to the authority conferred by the Borough Code, as follows:

- 1) The Code of the Borough of Callery, Chapter 64, Sanitary Sewer Rules and Regulations is hereby revised in its entirety. A copy of the revised Chapter is attached hereto as Exhibit A and incorporated herein.
- 2) The Borough reserves the right to adopt, from time to time, additional rules, regulations and standards as it shall deem necessary and proper relating to the Authority's sanitary sewer collection system.
- 3) The provisions of this Ordinance are severable. Should any section, sentence, clause, part or provision hereof shall be held illegal, invalid or unconstitutional by any court of competent jurisdiction, such decision shall not affect or impair the remaining sections, sentences, clauses, parts or provisions of this Ordinance. It is hereby declared to be the intent of the Borough that this Ordinance would have been enacted if such illegal, invalid or unconstitutional section, sentence, clause, part or provision had not been included herein.

- 4) The adoption of this Ordinance does not make legitimate sanitary sewer system development activity in the Borough under the provisions of the prior regulations illegal, and does not annul any litigation currently being pursued or that may be pursued in the future by the Borough under the provisions of the prior regulations.
- 5) Ordinances 2015-09 and 2016-13 and all other ordinances or regulations, or parts of such ordinances or regulations, in conflict with this Ordinance or inconsistent with its provisions, are hereby repealed to the extent necessary to give this Ordinance full force and effect.
- 6) This Ordinance shall take effect and be in force immediately.
