ORDINANCE NUMBER 2016-12

CALLERY BOROUGH, BUTLER COUNTY, PENNSYLVANIA

AN ORDINANCE ESTABLISHING WEIGHT LIMITS ON CERTAIN STREETS; REQUIRING WEIGHT LIMITS TO BE POSTED; IMPOSING RESTRICTIONS ON OVER-POSTED-WEIGHT MOTOR VEHICLES OPERATING UPON POSTED STREETS; EXEMPTING CERTAIN LOCAL TRAFFIC; PROVIDING FOR THE ADMINISTRATION AND ENFORCEMENT OF OVER-POSTED-WEIGHT VEHICLE PERMITS; AND IMPOSING PENALTIES FOR VIOLATIONS

NOW, THEREFORE, it is hereby enacted and ordained, pursuant to the authority vested by the Borough Code, as follows:

1. The Code of the Borough of Callery, Chapter 88, Vehicles and Traffic, is hereby revised by adding Article VI, Motor Vehicle Weight Limitations, a copy of which is attached hereto as Exhibit A and incorporated herein.
2. **AUTHORITY.** This Ordinance is enacted pursuant to the authority conferred by the Vehicle Code Act of 1976, June 17, P.L. 162, No. 81, § 1, effective July 1, 1977 (75 Pa.C.S.A. § 101 *et seq.*), as amended, and is intended to include and be subject to all provisions of Section 4902 of the Vehicle Code (75 Pa.C.S.A. § 4902) and all Pennsylvania Department of Transportation regulations promulgated or to be promulgated under the Vehicle Code.
3. **CONFLICTING REGULATIONS.** Where a conflict exists between any of the regulations or limitations prescribed in this Ordinance and any other regulation applicable to the same area, the more stringent limitation or requirement shall govern and prevail.
4. **SEVERABILITY.** If any of the provisions of this Ordinance or the application thereof to any person or circumstance are held invalid, such invalidity shall not affect other provisions or applications of the Ordinance which can be given effect without the invalid provision or application, and to this end, the provisions of this Ordinance are declared to be severable.
5. **REPEALS.** All ordinances or regulations, or parts of such ordinances or regulations, in conflict with this Ordinance or inconsistent with its provisions, are hereby repealed to the extent necessary to give this Ordinance full force and effect.
6. **EFFECTIVE DATE.** This ordinance shall be in full force and effect on November 14, 2016.

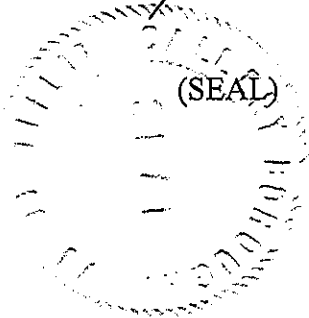
